The Esher Urban District (Tartar Hill, Cobham) Footpath Extinguishment Order, 1957.

NOTICE is hereby given that the above Order was made on the 26th day of October, 1957, and is about to be submitted to the Minister of Housing and Local Government for confirmation.

The Order relates to land in the Parish of Cobham in the Urban District of Esher on the north west side of Hogshill Lane and south west of Tartar Road.
