## NEW TOWNS ACT, 1946.

BRACKNELL DEVELOPMENT CORPORATION.

*Compulsory Purchase Order No. 17, 1957.*

NOTICE is hereby given that the Bracknell Development Corporation in pursuance of their powers under section 4 of the New Towns Act, 1946, on the 8th day of November, 1957, made an Order which has been submitted for confirmation by the Minister of Housing and Local Government authorising them to purchase compulsorily for the purposes of the New Town of Bracknell (or incidental thereto) the lands described in the Schedule hereto (being lands within the area designated by the Bracknell New Town (Designation) Order, 1949).

A copy of the Order, and of the map referred to therein have been deposited at the offices of the Corporation at Farley Hall, Binfield, Bracknell, Berkshire, and at Sussex Lodge, Wokingham Road, Bracknell, and will be open for inspection without payment of fee between the hours of 9.30 a.m. and 5 p.m. Monday to Friday, and 9.30 a.m. to 12 noon on Saturdays.

Any objection to the Order must be made in writing, stating the grounds of the objection, and addressed to the Minister of Housing and Local Government, Whitehall, London, S.W.1, before the 31st day of December, 1957.

The Minister is not, in all cases required to arrange for objection to be heard by a person appointed by him for that purpose. It is important, therefore, that an objection should include a full statement in writing of the grounds on which the objection is made as the objector may have no further opportunity to make such a statement.

Any owner or occupier of any land to which the Order relates may send to the Bracknell Development Corporation at the address below a request in writing to serve him with a notice that the Order has been confirmed, and naming a place where a copy of the Order and the map and of any descriptive matter annexed thereto may be seen. Such request should contain a statement of the name, postal address, and the interest in the land of the owner or occupier, and particulars sufficient to enable the extent and boundaries of the land to be identified.

## THE SCHEDULE.

Four parcels of land in the Parish of Bracknell in the Rural District of Easthampstead in the County of Berks.

(i) 2.2 acres or thereabouts of land with huts erected thereon having an access to the north west side of Harmans Water Road, Bracknell, bounded on the north west by property known as "Ramslade" and on the south east partly by property known as "Warren Lodge" and partly by property known as "D'Avanzo Villa" being part of Parcel No. 1193 on the Ordnance Survey Map Scale 1/2500 Berks Sheet XXXIX.14 (Revision of 1932).

(ii) 9.4 acres or thereabouts of vacant land immediately north east of Parcel No. (i) aforesaid having a frontage of approximately 585 feet to the north west side of Harmans Water Road and also being part of Parcel No. 1193 on the said map.

(iii) 1.66 acres or thereabouts of vacant land immediately north east of Parcel No. (ii) aforesaid having a frontage of approximately 130 feet to the

north west side of a lane leading north-eastwards from Harmans Water Road to Ralphs Ride, Bracknell, and also being part of Parcel No. 1193 on the said map.

(iv) 2.07 acres or thereabouts of land having an access to the south west side of Ralphs Ride, Bracknell, together with the bungalow and premises erected thereon and known as "The Retreat", Ralphs Ride aforesaid, being Parcel No. 1193K on the said map.

## TOWN AND COUNTRY PLANNING ACT, 1947.

The amendment became operative as from the 22nd day of November, 1957, but if any person aggrieved by it desires to question the validity thereof or of any provision contained therein on the ground that it is not within the powers of the Town and Country Planning Act, 1947, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the making of the amendment, he may, within six weeks from the 22nd day of November, 1957, make application to the High Court.

## ROAD TRAFFIC ACT, 1930—SECTION 46 (1).

ROAD AND RAIL TRAFFIC ACT, 1933—  
SECTION 29 (4).

1. Footpath from Belswains Farm between Oliver Road and Kings Avenue across the approach road to the Junior School and thence along the boundary of the school to Barnfield.

2. Footpath from Fairway south-east and south-west to the junction with the cart road and bridle path.

3. Footpath from near the Pond in Everest Way from Hillary Road to Montgomery Avenue.

4. Footpath from Windmill Road (almost opposite Turners Hill) proceeding at the rear and crossing Newfield Lane behind Windmill Road and Abel
