The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under Section 9 of the Finance Act, 1932, Section 7 of the Finance Act, 1934, and Section 1 of the Import Duties (Emergency Provisions) Act, 1939, viz.:—

The Import Duties (Drawback) (No. 17) Order, 1957, which reduces from 1s. 11d. to 1s. 0d. per lb. the rate of drawback allowable in respect of Customs duty paid on unblown hatters' fur used in the manufacture of exported hats, bonnets, etc.; and increases from 1\frac{2}{3} to 1.49 lb. in quantity of fur to be taken into account in calculating the amount of drawback allowable in respect of each pound of felt contained in the exported goods.

The Order comes into operation on the 2nd December, 1957, and has been published as Statutory Instruments 1957, No. 2023.
