"Now, therefore, with the consent of the Right Reverend George, Bishop of Chichester (in testimony whereof he has set his hand and affixed his episcopal seal to this Scheme), we, the said Church Commissioners, do humbly recommend and propose as follows, that is to say:—

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual

in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

And Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Chichester.

"We the Church Commissioners, acting in pursuance of the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend Arthur, Bishop of Bristol (in witness whereof he has signed this Scheme), with respect to the Church of Dodington in the Parish of Wapley with Codrington and Dodington in the Diocese of Bristol.

### "SCHEME.

- "As from the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the Church of Dodington in the Parish of Wapley with Codrington and Dodington shall be appropriated to the use hereinafter specified but subject to the conditions hereinafter contained:—
  - "1. The Church of Dodington shall be held by the Diocesan Board of Finance of the Diocese of Bristol (hereinafter called 'the diocesan authority') on trust to allow the same to be used as a private chapel to and for the benefit of the owner or occupier for the time being of the house now known as Dodington House subject to the terms of any licence or licences as the Bishop of the Diocese may from time to time issue.

"2. The owner of Dodington House shall be wholly responsible for the repair and maintenance of the Church and its fittings and for the insurance of the same against fire.

"3. The owner or occupier for the time being of Dodington House shall not effect or permit to be effected any alterations or additions in or to the interior or to the fabric of the said Church except with the consent in writing of the diocesan authority and in accordance with and subject to lawful authority.

"4. The diocesan authority may from time to time enter into agreements with the owner or occupier of Dodington House on consequential and ancillary matters in connection with the appropriation and use of the Church not repugnant to or inconsistent with the provisions of this Scheme.

"5. Nothing herein contained shall affect or diminish the jurisdiction of the Consistory Court of the diocese in respect of the Church.

"6. The Diocesan authority shall not dispose of the freehold of the said Church."

And Whereas the provisions of the Union of Benefices Measures, 1923 to 1952, and the Union of Benefices Rules, 1926 and 1930, relating to the preparation and submission of this Scheme have been duly complied with:
