"Thirdly: That so long as the Canonry which is at the date of this Scheme vacant remains vacant an annual sum of £250 (in addition to the yearly stipends hereinbefore mentioned) shall be paid to each of the four remaining Canons in respect of the extra duties undertaken by them during such vacancy. Such payment to the four remaining Canons to cease forthwith on an appointment being made to the said vacant Canonry.
