EXPLOSIVES ACT, 1875.

The Secretary of State for the Home Department gives notice that he proposes to make byelaws under sections 37 and 39 of the Explosives Act, 1875, amending (a) the proviso to byelaw 2 of the byelaws with respect to the conveyance, loading or unloading of gunpowder and other explosives in certain places made on 20th September, 1924, as amended by Orders of the Secretary of State made respectively on 11th December, 1939, and 7th February, 1944, and (b) byelaw 4 of the aforementioned byelaws as amended by the Explosives (Conveyance) (Private Railways) Byelaws made by the Secretary of State on 23rd July, 1948.

The effect of the byelaws is to increase the number of detonators which may be carried in the same carriage or boat with explosives of another Class or Division, subject to certain conditions, from 10,000 to 20,000 and to increase the amount of explosives which may be conveyed on certain types of well constructed vehicles from 6,000 lbs. to 8,000 lbs.
