CITY OF WINCHESTER.

railings surrounding any grave or tombstone therein:

(3) for the several purposes of the application or for purposes connected with, incidental to or consequent on these purposes, to make such alteration or amendment of the said local Act or any other local Act as may be necessary or desirable.
