Survey of Public Rights of Way.

NOTICE is hereby given that pursuant to Part IV of the National Parks and Access to the Countryside Act, 1949, the Devon County Council have carried out a survey of all lands within the areas of the Borough of Okehampton and the Rural District of Okehampton, in the County of Devon, over which a right of way is alleged to subsist and have prepared a Draft Map and Statement showing and describing all public rights of way which in their opinion subsisted or were reasonably alleged to subsist on 1st December, 1957.

A copy of the Draft Map and Statement has been deposited for public inspection at the offices of the undersigned at The Castle, Exeter.

CHIPPING NORTON RURAL DISTRICT COUNCIL.

*The Chipping Norton Rural District Council
(Hensington Without) Diversion Order, 1957.*

NOTICE is hereby given that on the 14th day of January, 1958, the Minister of Housing and Local Government confirmed the above Order.

The effect of the Order will be to create a public right of way on foot of a width of approximately four feet passing across field O.S. No. 58 in the parish of Hensington Without from a stile at point "C" (i.e. a point on Green Lane) to a stile at point "B" (i.e. a point on the existing footpath on the easterly boundary of the garden at Apiary House, Green Lane, Woodstock, as shown coloured red on the map annexed to the Order, and to extinguish on the 14th April, 1958, the public right of way of a width of approximately four feet passing diagonally across the garden at Apiary House, Green Lane, Woodstock, in a north easterly direction from point "A" (i.e. a point on Green Lane) to a stile at point "B" aforesaid as shown coloured yellow on the map annexed to the Order.

A certified copy of the Order and of the map contained in the Order as confirmed by the Minister has been deposited at the Council Office, Hillside, Albion Street, Chipping Norton, and will be open for inspection, free of charge, between the hours of 9 a.m. and 5 p.m. on weekdays, except Saturdays, and on Saturdays between the hours of 9 a.m. and 12 noon.

The Order becomes operative as from the 24th day of January, 1958, but if any person aggrieved

by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the National Parks and Access to the Countryside Act, 1949, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice make application to the High Court.

*The Edmonton Conduit Lane (Footbridge)
Extinguishment Order, 1958.*
