 "(1) As soon as conveniently may be after the union has taken effect the church of Saint Paul, Ramsgate, shall be taken down and the materials and site thereof, together with any ground annexed thereto and necessary for the use and enjoyment thereof, shall be sold and disposed of by us at such time or times and in such manner in all respects as to us shall seem expedient subject to the conditions and restrictions imposed by the said Union of Benefices Measures. - "(2) The not proceeds to arise from such sale or
- "(2) The net proceeds to arise from such sale or sales, after payment of the expenses attendant thereon and upon the taking down of the church and all other expenses incidental to these matters, shall be placed to the credit of the Expenses Fund of the said diocese established pursuant to the 32nd Section of the Union of Benefices Measure, 1923.

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and humbly lay before Your Majesty in Council the following Scheme for constituting a new parish to be taken out of the parish of Holy Trinity, Coventry, in the diocese of Coventry.

"Whereas we, the Church Commissioners, are satisfied that the spiritual interests of the area defined in the subjoined Schedule and delineated on the map hereto annexed would be best served by con-

map hereto annexed would be best served by constituting it a new parish:

"And whereas we are satisfied that a suitable endowment therefor will be provided:

"And whereas there is within the said area a consecrated church known as Saint John the Divine, Willenhall, which has been approved by us as suitable to be the parish church of the new parish and of which the patronage belongs to the incumbent for the time being of the benefice of Holy Trinity, Coventry:

"Now, therefore, with the consent of the Right Reverend Cuthbert, Bishop of Coventry (in testimony whereof he has set his hand and affixed his episcopal seal to this Scheme), we, the said Church Commissioners, do humbly recommend and propose as follows, that is to say:—
