#### LEICESTER COUNTY COUNCIL.

THE COUNTY OF LEICESTER (FIELD STREET, SHEPshed) (PROHIBITION OF WAITING) ORDER, 1958.

THE Leicester County Council proposes to make an Order under the Road Traffic Act, 1930, as amended, the effect of which will be to prohibit the waiting of vehicles in Field Street, Shepshed, between the Bull Ring and Britannia Street between the hours of 10 a.m. and 4 p.m. daily.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary:—

(a) to enable a person to board or alight from the vehicle;

(b) to enable goods to be loaded or to be unloaded from the vehicle; or

(c) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the length of road so referred to or the laying, erection, alteration or repair in or near to the length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or

electricity, or of any telegraph line as defined in the Telegraph Act, 1878.

#### COUNTY BOROUGH OF BLACKPOOL.

THE BLACKPOOL (TRAFFIC REGULATION) AMENDMENT ORDER (NO. 1) 1958.

THE Council of the County Borough of Blackpool propose to make an Order under the Road Traffic Act, 1930, as amended, the effect of which will be to amend the Blackpool (Traffic Regulation) Order (No. 2) 1955 by substituting in the Schedule thereto the words "Squires Gate Lane" for the words "Stanley Road". This amendment is required by reason of the re-naming of Stanley Road to Squires Gate Lane. The effect will also be that no person shall (except when proceeding from one dual carriageway to the other) drive or cause or permit to be driven any vehicle on either of the dual carriageways in Squires Gate Lane Blackpool from its junction with Sycamore Avenue Blackpool westwards for a distance of approximately 635 yards to the Borough Boundary otherwise than so as to keep the central islands on the right hand or off side of the vehicle.
