KNIGHTON URBAN DISTRICT COUNCIL.

*Knighton Urban District Council (Garth Holding)
Public Path Diversion Order, 1957.*

NOTICE is hereby given that on the 20th day of February, 1958, the Minister of Housing and Local Government confirmed the above Order.

The effect of the Order is to divert the public right of way running from a stile in the eastern boundary fence of the field adjoining Garth Holding farmhouse to the Penybont Road at its junction with Garth Lane to a line running from the said stile to the Penybont Road adjacent to the existing gateway and 35 yards to the north-east of the road junction.

A certified copy of the Order and of the map contained in the Order as confirmed by the Minister has been deposited at Town Hall, Knighton, and will be open for inspection free of charge during usual office hours.

The Order becomes operative as from the 28th day of February, 1958, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the National Parks and Access to the Countryside Act, 1949, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice make application to the High Court.

THE ESHER URBAN DISTRICT COUNCIL.

*The Esher Urban District (Tartar Hill, Cobham)
Footpath Extinguishment Order, 1957.*

NOTICE is hereby given that on the 20th day of February, 1958, the Minister of Housing and Local Government confirmed the above Order. The effect of the Order is to extinguish at the expiration of twenty-one days from the said 20th day of February, 1958, that is to say as from the 14th day of March, 1958, the Public Right of Way over the two lengths of public footpath having a width of six feet or thereabouts between the points respectively marked "A" to "B" and "C" to "D" on the map annexed to the Order and respectively the one leaving Hogshill Lane, Cobham in the County of Surrey, on its north west side at a point approximately 125 feet southwards of the junction of Tartar Road with Hogshill Lane aforesaid and proceeding in a north westerly direction for a distance of 221 feet or thereabouts from the said point marked "A" on the said map (being its junction with Hogshill Lane) to the said point marked "B" on the said map (being its junction with Freelands Road Extension on its south east side) and the other proceeding in a northerly direction for a distance of 171 feet or thereabouts from the said point marked "C" on the said map (being the junction of the said footpath with Freelands Road Extension on its north west side) to the said point marked "D" on the said map (being its junction with the private footpath at the rear of Nos. 20 to 30 Tartar Road aforesaid) and both forming two parts of the public footpath (now divided the one from the other by Freelands Road Extension aforesaid) which formerly extended from Hogshill Lane aforesaid in a north westerly direction and connected with Canada Road, Cobham aforesaid.

A certified copy of the Order and of the map contained in the Order as confirmed by the Minister has been deposited at the Council Offices, High Street, Esher, and will be open for inspection free of charge between the hours of 10 o'clock in the forenoon and 5 o'clock in the afternoon on weekdays and between the hours of 10 o'clock in the forenoon and 12 noon on Saturdays.

The Order becomes operative as from the 28th day of February, 1958, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the National Parks

and Access to the Countryside Act, 1949, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice make application to the High Court.

*The Hatfield Rural District Council (Footpath No. 10)
Diversion Order, 1958.*

NOTICE is hereby given that the above Order was made on the 18th day of December, 1957, and is about to be submitted to the Minister of Housing and Local Government for confirmation.

The Order relates to land situate in the Parish of North Myms.

The effect of the Order will be to divert part of Footpath No. 10 which runs from Hawkshead Farm to the north-west corner of Field No. 272 and thence into Warrengate Road and is coloured brown on the map annexed to the Order, to a new line shown coloured purple on the said map from Hawkshead Farm along the eastern and northern boundaries of Field No. 272, across a stile to be erected, then along the southern and western boundaries of Field No. 289A into Footpath No. 11 and thence westwards to Warrengate Road.

SELBY RURAL DISTRICT COUNCIL.

*Selby Rural District Council (Barlow) Diversion
Order, 1957.*

NOTICE is hereby given that on the 11th day of February, 1958, the Minister of Housing and Local Government confirmed with modifications the above Order.

The effect of the Order is to divert as from nine weeks following the date of confirmation of the Order the following public right of way over land situate in the Parish of Barlow, shown coloured brown and marked "A" on the map annexed to the Order, commencing at the north-east corner of Carr Plantation and proceeding in a south-easterly direction through field O.S. 16 Sheet CCXXXVI.4 Yorkshire (West Riding) (1890 Edition) for a distance of approximately 270 yards and thence proceeding in a south-easterly direction through field O.S. 14 for a distance of approximately 230 yards to the south-west corner of Wind Covert and then proceeding south-east through field O.S. 3 Sheet No. CCXXXVI.4 and CCXXXVI.8 for a distance of approximately 340 yards and connecting up with the footpath suggested to be diverted at field No. O.S. 3. The footpath is to be closed at the expiration of nine weeks from the confirmation of the Order.

There shall be at the expiration of nine weeks from the confirmation of this Order a public right of way on foot over the land situate in the Parish of Barlow shown coloured purple and marked "B" on the map annexed to the Order, commencing at the north-east corner of Carr Plantation and proceeding in a south-easterly direction through field O.S. 16 for a distance of approximately 400 yards and then in a southerly direction through field O.S. 15 for a distance of
