TENDERS FOR TRIEASURY BILLS.

TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England on Friday, the 21st March, 1958, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £260,000,000.

2. The Bills will be in amounts of £5,000, £10,000. £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 24th March, 1958, to Saturday, the 29th March, 1958, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount of not less than £50,000 and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part, and payment in full of the amounts due in respect of such ment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, ill.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

Treasury hereby give notice that they have made an Order under section 9 of the Finance Act, 1932, and section 1 of the Import Duties (Emergency Provisions) Act, 1939, viz.:—

The Import Duties (Drawback) (No. 7) Order, 1958, which increases from 7s. 3d. to 7s. 9d. per cubic foot the rate of drawback allowable in respect of Customs duty paid on veneers used in the manufacture of certain exported sewing-machine woodwork. The Order also amends the quantities of square course wood and timber and of veneers of square-sawn wood and timber and of veneers which are to be taken into account in calculating the drawback payable on such woodwork.

The Order comes into operation on the 18th March, 1958, and has been published as Statutory Instruments 1958, No. 390.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under section 9 of the Finance Act, 1932, section 1 of, and Part III of the Second Schedule to, the Ottawa Agreements Act, 1932, section 7 of the Finance Act, 1934, and section 1 of the Import Duties (Emergency Provisions) Act, 1939, viz.:—

The Import Duties (Drawback) (No. 6) Order, 1958, which reduces the rates of drawback allowable in respect of Customs duty paid on linseed oil used in the manufacture of certain kinds of exported goods. For exported paints, printers' inks, floor coverings, fishing nets, certain blocks and tiles, etc., drawback is reduced from £14 10s. 0d. to £12 10s. 0d. per ton of linseed oil; and for
