**Office of the High Commission of India.**

**TOWN AND COUNTRY PLANNING ACT, 1947.**

The Minister of Transport and Civil Aviation hereby gives notice that he has made an Order under s. 49 of the Town and Country Planning Act, 1947, entitled "The Stopping up of Highways (County of Devon) (No. 2) Order, 1958" authorising the stopping up of a length of footpath crossing the site of the Magnetic Observatory at Hartland, and requiring the provision of a new footpath repairable by the inhabitants at large for which the highway authority is to be the Devon County Council.
