WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 5th day of June, 1958, in the words and figures following, that is to say:—

"We, the Church Commissioners, in pursuance of the Church Patronage Act, 1870, and of the Acts therein mentioned, have prepared the following Scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called 'the said benefice') of East Cowick in the County of York and in the diocese of Sheffield.

"Whereas we are satisfied that Edith Bridget Cooper Hawkesworth of Badgeworth Manor near Cheltenham in the County of Gloucester, Widow, Charles Peter Elmhirst Hawkesworth of Moser's Hall, The Schools, Kingsland, Shrewsbury in the county of Salop, Schoolmaster, and John Walter Cooper Hawkesworth of Malton in the County of York, Solicitor, are the patrons or the persons now entitled for their several respective interests to present or nominate to the said benefice pursuant to the Will dated 8th June, 1905, of Samuel Joshua Cooper deceased formerly of Mount Vernon near Barnsley in the County of York:

"And whereas the said Edith Bridget Cooper Hawkesworth, Charles Peter Elmhirst Hawkesworth and John Walter Cooper Hawkesworth desire to transfer the advowson of the said benefice to the Bishop of Sheffield for the time being and are consenting to this Scheme (in testimony whereof they have executed the same):

"Now therefore, with the consent of the Right Reverend Leslie, Bishop of Sheffield (in testimony whereof he has executed this Scheme), we, the said Church Commissioners, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order, the whole advowson or perpetual right of patronage of and presentation to the said benefice shall be transferred to the said Leslie, Bishop of Sheffield, and his successors in the same Bishopric and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the Bishop of Sheffield for the time being."

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to

ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Acts.

And Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Sheffield.
