The QUEEN has been graciously pleased to approve the award of the British Empire Medal for Gallantry (Military Division) in recognition of gallant conduct to the undermentioned:—

21.146537 Corporal Karnabahadur Limbu, 10th Princess Mary's Own Gurkha Rifles.
On the 13th January, 1958, Conporal Karnabahadur, hearing the cries of a woman, rushed out of his quarters to discover that a three year old child had fallen fifteen feet, through a small trapdoor into a septile tank. Disregarding his own safety he immediately climbed through the trap door and let himself down into the depths where he remained floating and holding the child secure from drowning until others came to his assistance. assistance

He did not hesitate to face the danger of death by drowning in appalling circumstances and the added risk of asphyxiation for the sake of saving the life of a child.
