The Tuberculosis (Southern England Attested Area) Order, 1958

(Made 22nd September 1958)

The above Order, which comes into operation on 1st October, 1958, declares an area in England set out in the Schedule to the Order to be an Attested Area for purposes connected with the control of tuberculosis. The Scheduled Area remains subject to the provisions of the Tuberculosis (Area Eradication) Order, 1950 (S.I. 1950/2006) as amended by the Tuberculosis (Area Eradication) Amendment Order, 1954 (S.I. 1954/762) and the Tuberculosis (Area Eradication) Amendment Order, 1955 (S.I. 1955/1449).
