"We, the Church Commissioners, acting in pursu-ance of the Pastoral Reorganisation Measure, 1949, and the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend John, Bishop of Derby (in witness whereof he has signed this Scheme), for effecting the union of the benefice of Fenny Bentley, the benefice of Thorpe and the benefice of Tissington, all situate in the diocese of Derby.

" SCHEME

"1. Union of Benefices. The benefice of Fenny Bentley, the benefice of Thorpe and the benefice of Bentley, the benence of Thorpe and the benence of Tissington shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Fenny Bentley, Thorpe and Tissington' but the parishes of the said benefices shall continue in all respects distinct.

"2. Taking effect of union. "(1) If upon the day when any Order of Your Majesty in Council affirming this Scheme is pub-lished in the London Gazette all of the said bene-fices shall be vacant the union shall forthwith take effect:

"(2) If upon that day the benefice of Tissington only shall be vacant the union shall take effect upon the first avoidance of that one of the other two bene-"(3) If upon that day the benefice of Tissington

and one other of the said three benefices shall be vacant the union shall take effect upon the first avoidance of the remaining one of the three benefices. "3. Parsonage House. Without prejudice to the exercise before the date when the union takes effect

exercise before the date when the union takes effect of any of the powers conferred by the Parsonages Measures, 1938 and 1947, upon the union taking effect the parsonage house at present belonging to the benefice of Thorpe shall (if at that date it so belongs to the said benefice) be the house of resi-dence of the incumbent of the united benefice and the parsonage house at present belonging to the benefice of Fenny Bentley (if at that date it so belongs) together with the site and appurtenances thereof and the grounds usually occupied and enjoyed therewith shall, as soon as conveniently may be be thereof and the grounds usually occupied and enjoyed therewith shall, as soon as conveniently may be, be sold and disposed of by us at such time or times and in such manner in all respects as to us shall seem expedient and the net proceeds of such sale or sales shall be placed to the credit of the Expenses Fund of the said diocese established pursuant to the 32nd Section of the Union of Benefices Measure, 1022

1923. "4. Patronage. "4. Patronage. In every series of three successive turns of presentation to be made to the united benefice after the union has taken effect the patron of the benefice of Fenny Bentley shall have the first turn, the patron of the benefice of Tissington the second turn, and the patron of the benefice of Thorpe the third turn."

And whereas the provisions of the Union of Bene-fices Measures, 1923 to 1952, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the preparation and sub-mission of this Scheme have been duly complied with:
