being the incumbent of the benefices of Sneyd and Saint Werburgh, Burslem, all that part of the parish of Saint Werburgh, Burslem, which is described in the Schedule hereto and delineated on the map hereto annexed shall, upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette, be severed from that parish and be annexed to the parish of Sneyd.

"2. Taking down of church
"(1) The said church shall be taken down and the materials and site thereof, together with any ground annexed thereto and necessary for the use and enjoyment thereof, shall be sold and disposed of by us at such time or times and in such manner in all respects as to us shall seem expedient subject to the con-ditions and restrictions imposed by the said Union of Benefices Measures.

Benefices Measures.

"(2) The net proceeds to arise from such sale or sales, after payment of the expenses attendant thereon and upon the taking down of the said church and all other expenses incidental to these matters, shall be placed to the credit of the Expenses Fund of the said diocese established pursuant to the 32nd Section of the Union of Benefices Measure, 1923.

"(3) The furnishings, that is to say, the font, communion table, plate used for the purpose of the Holy Communion, bells, organ and other furniture and fittings of the said church or such of them as the bishop of the said diocese may select, shall be trans-

"All that part (coloured pink on the map hereto annexed) of the parish of Saint Werburgh, Burslem, which is bounded on the southwest, south and southeast by the parish of Sneyd and on the remaining sides by an imaginary line commencing on the boundary which divides the parish of Sneyd from the parish of Saint Werburgh, Burslem, in the middle of Hamil Road opposite the middle of the southeastern end of Lorne Street and proceeding thence northwestwards to and along the middle of Lorne Street and in a straight line in continuation thereof to a point in the middle of Bycars Lane and continuing thence westwards along the middle of Bycars Lane and in a straight line in continuation thereof to a point in the middle of Bycars Road and continuing thence southwestwards along the middle of Bycars thence southwestwards along the middle of Bycars Road to the boundary which divides the parish of Saint Werburgh, Burslem, from the parish of Sneyd."
