Saint Nicholas, Guildthe parishes of Worplesdon; Saint Nicholas, Guildford; and Emmanuel, Stoughton, Stoke-next-Guildford, all of which parishes are situate in the diocese of Guildford.

"Whereas we are satisfied (1) that it is desirable that the boundaries of the parishes of Saint Nicholas, Guildford, and Emmanuel, Stoughton, Stoke-next-Guildford, should be altered in the manner described in Part I of the subjoined Schedule and delineated on the map hereto annexed; and (2) that the spiritual interests of the area defined in Part II of the said Schedule and delineated on the said map would be best served by constituting it a new parish and that a suitable endowment therefor will be provided:

"And whereas we have not approved any conse-crated church within the area described in Part II of the said Schedule as suitable to be the parish church of the new parish:

As from the date of the publication in the London Gazette of any Order of Your Majesty in Council confirming this Scheme the boundaries of the said parishes of Saint Nicholas, Guildford and Emmanuel, Stoughton, Stoke-next-Guildford, shall be altered in the manner described in Part I of the Schedule hereto and delineated on the map annexed hereto.

"2. (a) As from the date of the licence thereto of a Minister the area defined in Part II of the said Schedule and delineated on the said map shall be a
