"All those contiguous parts (together coloured pink on the map annexed hereto) of the parishes of Worplesdon; Saint Nicholas, Guildford; and Emmanuel, Stoughton, Stoke-next-Guildford, which taken together are bounded on the east by the parish of Stoke-next-Guildford and on the remaining sides by a continuous imaginary line commencing at a point on the boundary which divides the parish of Emmanuel, Stoughton, Stoke-next-Guildford, from the parish of Stoke-next-Guildford in the middle of the bridge which carries the Guildford to Woking line of the British Railways (Southern Region) over Woodbridge Road, and continuing from that point westwards to and along the middle of Woodbridge Hill and along the middle of Aldershot Road to the present boundary of the Municipal Borough of Guildford generally southwestwards along the said municipal boundary to the middle of the Aldershot to Guildford line of the British Railways (Southern Region), and generally eastwards along the middle taken together are bounded on the east by the parish Region), and generally eastwards along the middle of the said railway line and the boundary dividing the Westborough and Onslow Ward of the Muni-cipal Borough of Guildford to the boundary which divides the parish of Stoke-next-Guildford from the parish of Saint Nicholas, Guildford."

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parishes of Saint Mark, Newby, and Saint Columba, Scarborough, both in the diocese of York. York.

"Whereas we are satisfied that it is desirable that

the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

"And whereas the Right Honourable and Most Reverend Arthur Michael, Archbishop of York con-

sents to the proposed arrangements (in testimony whereof he has executed this Scheme):

"Now, therefore, we, the said Church Commissioners, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes of Saint Mark, Newby and Saiat

Columba, Scarborough, shall be altered in the manner described in the Schedule hereto and delineated on the map annexed to this Scheme.

And whereas the Minister of Housing and Land

And whereas the Minister of Housing and Local Government, after giving to the Incumbent and Churchwardens of the said Parish of Long Melford in the County of Suffolk, ten days' previous notice of his intention in that behalf, has, under the provisions of the said Burial Acts, 1853 and 1855, as visions of the said Burial Acts, 1853 and 1853, as amended by subsequent enactments, made a Representation to Her Majesty in Council that, for the protection of the Public Health the said Order in Council of the 23rd June 1891 should be varied so as to provide that burials should be discontinued forthwith and entirely in the whole of the Churchyard of the said Parish Church of Long Melford in the County of Suffolk:

Provided that-

(a) In the said Churchyard, in the four grave spaces reserved by faculty in which no interment has heretofore taken place, the burial may be allowed at their decease of the bodies of members of the Parker family.

grave.
