#### TENDERS FOR TREASURY BILLS

1. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different currencies and for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part, and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not

precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

Investment allowances (Fuel Economy Plant) Order, 1958.

Section 15 (3) (b), Finance Act, 1956, provides that investment allowances are to be continued for expenditure incurred after 17th February 1956, on prescribed fuel-saving plant if it is installed by way of modification or replacement of plant in use in the United Kingdom. The Investment Allowances (Fuel Economy Plant) Order, 1957 (which superseded an earlier order) prescribes a list of fuelsaving plant and the conditions, if any, upon which such plant is prescribed. The present Order, as from the date when it comes into operation, pre-scribes the following additional items:

(a) gas-tight sealing dampers

(b) necessary operating equipment for gas-tight sealing dampers, of types not suitable for use in connection with other dampers.
