- (2) the aggregate number of hours of overtime allowed in any calendar year.

Draft Quarries (Ropeways and Vehicles) Regulations, 1958

The Minister of Power, in accordance with the pro-visions of section 142 of, and Part 1 of the Second Schedule to, the Mines and Quarries Act, 1954, hereby gives notice that he intends to make General Regula-tions under sections 141 and 110 of the Act, entitled the Quarries (Ropeways and Vehicles) Regulations, 1958.

Section 110 of the Act provides that after the expiration of the period of two years beginning with the commencement of the Act (that is to say after 31st December 1958), no ropeway and no vehicle running December 1955), no ropeway and no venicie running on rails shall, except in such cases and in accordance with such conditions, if any, as may be prescribed, be used at a quarry for the purpose of carrying persons employed thereat to or from their working places. The Regulations will apply only to those quarries where ropeways or vehicles running on rails are used for carrying persons. They will not extend to other types of apparatus for carrying persons such as shafts types of apparatus for carrying persons such as shafts or cranes.
