"And whereas Order in Council dated the 15th day of January, 1849, which was confirmed by Order in Council dated the 5th day of December, 1865, provides for the award of Good Conduct Badges and for the payment of Good Conduct Badge Pay to ratings and other ranks of Your Majesty's Naval and Marine Forces:
