CITY OF ROCHESTER

The City of Rochester (Traffic Regulation) (No. 4) Order, 1958

On the 23rd day of December 1958, the Mayor, Aldermen and Citizens of the City of Rochester (acting by the Council) made an Order under the Road Traffic Act, 1930, as amended, the effect of which is to provide for the following:

Length of road affected

In the City of Rochester High Street (lower) (Route A.2)

(1) Both sides from a point 25 feet east of its junction with Unilateral waiting by vehicles between the hours Gundulph Road, westerly for a distance of 645 feet.

Unilateral waiting by vehicles between the hours of 8 a.m. and 6 p.m.

(2) The North side (a) from a point 25 feet west of its junction with Bingley Road, westerly for a distance of 848 feet; and (b) from a point 355 feet west of its junction with Nags Head Lane, north-westerly for a distance of 248 feet.

(3) The South side (a) from a point 25 feet west of its junction with Bingley Road, westerly for a distance of 848 feet; and (b) from a point 355 feet west of its junction with Nags Head Lane, north-westerly for a distance of 248 feet.

Nags Head Lane, north-westerly for a distance of 185 feet.

No waiting by vehicles.

THE SCHEDULE ABOVE REFERRED TO

The Order prohibits any person from causing or permitting any vehicle to wait between the hours of 8 a.m. and 8 p.m. on even dates on the north-west side and on odd dates on the south-east side of Melson Street, and limits waiting to 30 minutes in any hour on the side on which waiting is not for the time being prohibited.

Exceptions are provided in the Order enabling a vehicle to wait, upon the direction or with the permission of a police constable in uniform; to enable persons to board or alight to enable goods to be loaded or unloaded; to enable a vehicle to be used for building operations or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein or in connection with a funeral.

BOROUGH OF MARGATE

The Borough of Margate (Eaton Road and Belgrave Road) (Beresford Gardens) (Prohibition of Waiting) (Nos. 1 and 2) Orders, 1959.

The Margate Borough Council proposes to make Orders under the Road Traffic Act, 1930, as amended, which will, subject to the usual exemptions:

(1) Extend the existing "No waiting" restrictions on Eaton Road and Belgrave Road by prohibiting vehicles waiting between 10 a.m. and 10 p.m. from 15th May to 15th September on the undermentioned parts of the said roads. The Order will not affect the one-way traffic system on these roads:

Eaton Road-East side from its junction with Eaton Eaton Road—East side from its junction with Eaton Hill to a point opposite the northern boundary wall of No. 46 Eaton Road. (Present restrictions 10 a.m. to 7 p.m.)

Eaton Road—West side from its junction with Belgrave Road to a point opposite the southern boundary wall of No. 21 Eaton Road. (At present not rectificate)

Belgrave Road—West side from its junction with
Marine Terrace to its southerly junction with
Eaton Road. (Present restrictions 10 a.m. to 7 p.m.)

Belgrave Road—East side from its junction with

Marine Gardens to its junction with Eaton Hill. (Present restrictions 10 a.m. to 7 p.m.)

(2) Prohibit vehicles waiting between 8 a.m. and 10 p.m. from 15th May to 15th September on the south side of Beresford Gardens between Devonshire Gardens and Princes Gardens and between Avenue Gardens and Northumberland Avenue.
