Town and Country Planning Act, 1947

The Minister of Transport and Civil Aviation hereby gives notice that he has made an Order under section 49 of the above Act, entitled "The Stopping up of Highways (City and County Borough of Sheffield) (No. 2) Order, 1959," authorising the stopping up of a length of footpath at Poole Road, Darnall, Sheffield, and requiring the provision of a new footpath.

*Parking Places on the Highway
Borough of Richmond*

The Minister of Transport and Civil Aviation in accordance with the London Traffic Act, 1924, section 10, as amended, proposes to refer to the London and Home Counties Traffic Advisory Committee for their advice and report a proposal that he should make Regulations to alter the limits of the official street parking places in Princes Road, Kew:

Princes Road: From 8 a.m. to 8 p.m., on west side, (a) from a point 51 feet south of Kew Gardens Road southwards for 84 feet; (b) from a point 236 feet south of Kew Gardens Road southwards for 84 feet; (c) from a point 351 feet south of Kew Gardens Road southwards for 100 feet. At an angle of 45° to kerb and with near rear wheel of vehicle by kerb "A."
