#### NYASALAND

The Secretary of State for the Colonies has appointed a Commission of Inquiry for the purpose of inquiring into the recent disturbances in Nyasaland, by a Warrant in the following terms:

Warrant Appointing The Honourable Mr. Justice Devlin and others to inquire into certain matters concerning Nyasaland

I, the Right Honourable Alan Tindal Lennox-Boyd, Member of Parliament, one of Her Majesty's Principal Secretaries of State, by virtue and in exercise of all powers enabling me in that behalf, do hereby direct and declare as follows:---

1. I hereby appoint The Honourable Mr. Justice Devlin, Sir John Ure Primrose, Knight, Sir Percy Wyn-Harris, Knight Commander of the Most Distin-guished Order of Saint Michael and Saint George, Member of the Most Excellent Order of the British Empire and Edgar Trevor Williams, Companion of the Most Honourable Order of the Bath, Commander of the Most Furgulart Order of the Bath, Commander of the Most Fronoutable Order of the British Empire, Companion of the Distinguished Service Order, to be a Commission of Inquiry for the purpose of inquiring into the recent disturbances in Nyasaland and the events leading up to them and to report thereon

2. And I further appoint The Honourable Mr. Justice Devlin to be Chairman of the said Commis-sion of Inquiry

3. I direct that the Chairman may appoint a person to be the Secretary of the said Commission of Inquiry and such other persons to assist the said Commission of Inquiry as he may consider necessary

4. And I further direct that any three of the mem-bers of the said Commission of Inquiry shall form a quorum for the purpose of discharging any of the functions (other than that of reporting) of the Commission

5. And I further direct, in pursuance of the powers vested in me, that the said Commission of Inquiry shall have power:---

- (a) to examine witnesses on oath;
- (b) to call for the production of documents;
- (c) to make such rules for their own guidance and the conduct and management of proceedings before them and as to the time and place for their sitting as they may from time to time think fit

6. And I further direct, in pursuance of the said powers, that no member of the Commission of Inquiry shall be liable to any action or suit for any matter or any thing done by him as such member

7. And I further direct, in pursuance of the said powers, that the Inquiry shall be held in private

8. And I further direct, in pursuance of the said powers, that a witness before the said Commission of Inquiry shall be entitled to have his legal representative present while he gives his evidence but that a witness shall not nor shall his legal representative

be present at a sitting of the said Commission of Inquiry while any other person gives evidence

Provided that this direction shall not be construed as prohibiting the presence of any witness or prospec-tive witness while another witness is giving his evi-dence if both so agree and the said Commission of Inquiry permits

9. This Warrant may be amended, added to or revoked by any further Warrant supplemental thereto under the hand of one of Her Majesty's Principal Secretaries of State
