The Queen's Most Excellent Majesty in Council

Whereas by section 3 of the Naval and Marine Pay and Pensions Act, 1865 (28 & 29 Vict. c. 73.), it is grants or other allowances in the nature thereof payable in respect of services in Her Majesty's naval or marine force to a person being or having been an officer, seaman or marine, or to the widow or any relative of a deceased officer, seaman or marine, shall be paid in such manner, and subject to such restrictions, conditions and provisions, as are from time to time directed by Order in Council:

And whereas Her Majesty deems it expedient to make further provision for the widows of officers and the widows and certain other dependants of ratings, deceased in consequence of service during the 1914 World War:

Now, therefore, Her Majesty, in exercise of the powers conferred upon Her as aforesaid and of all other powers whatsoever Her thereunto enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

1. After Article 20 there shall be inserted the following Article:

"20a. Grants' to elderly widows and women who lived as wives.—Where a widow in receipt of a pension awarded under Article 11, 13, 17A, 17B or 19 of the 1920 Order or under Article 11, 13, 16A, 16B or 17A of the 1921 (Officers) Order or under Article 11, 13, 16A, 16B or 17A of the 1921 (Warrant Officers) Order or under Article 14 of this Order or where a woman in except of a of this Order, or where a woman in receipt of a pension awarded under Article 20 of the 1920 Order, has attained the age of 70 years, she may be awarded a grant at the rate of £26 a year in the case of a widow of an officer or at the rate of 10s. a week in any other case."
