### " SCHEME

"1. Union of Benefices and Parishes. The bene-fice of Saint Paul, Chichester, and the benefice of Saint Bartholomew, Chichester, shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Saint Paul and Saint Bartholomew, Chichester', and the parishes of the said benefices shall also be united into one parish for erclesization purposes into one parish for ecclesiastical purposes.

"2. Taking effect of union. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend Frederick John Jackson if he is then incumbent of the said benefice of Saint Paul, Chichester, shall, with his consent (which has been given to us in writing), be the first incumbent of the united benefice.

"3. Parish Church. The parish church of the parish of Saint Paul, Chichester, shall be parish church of the united parish.

After the union has taken effect the marriage registers current at the church of Saint Bartholomew, Chichester, shall be dealt with in accordance with section 62 of the Marriage Act, 1949, and the register books (if any) of baptisms and burials and other the records and muniments deposited in the said church shall be transferred to the parish church of Saint Paul, Chichester.

"5. Parsonage House. Upon the union taking effect the parsonage house at present belonging to the benefice of Saint Paul, Chichester, shall be the house of residence of the incumbent of the united benefice.

of residence of the incumbent of the united benefice. "6. Patronage. With the consent (testified as afore-said) of the Right Reverend Roger, Bishop of Chichester, being the patron of the benefice of Saint Bartholomew, Chichester, and the consent (which has been given to us in writing) of the Dean and Chapter of the Cathedral Church of the Holy Trinity, Ichichester (hereinafter called 'the said Dean and Chapter'), being the patrons of the benefice of Saint Paul, Chichester, upon the union taking effect the patronage of the benefice of Saint Bartholomew, Chichester, shall, without any conveyance or assurance other than this Scheme, be surrendered in favour of the said Dean and Chapter and the patronage of the united benefice shall belong wholly patronage of the united benefice shall belong wholly to the said Dean and Chapter.

"7. Appropriation of the Church of Saint

Bartholomew, Chichester. "Upon the union taking effect the church of Saint Bartholomew, Chichester, shall be appropriated to the use specified in the First Schedule hereto, but subject to the conditions so specified.
