"2. Archdeaconry and Rural Deanery

"The district (or parish) shall be in the Archdeaconry of Ipswich and in the rural deanery of Ipswich.

"All those contiguous parts (together coloured pink on the map annexed hereto) of the parishes of Saint Mary, Stoke; Belstead; and Sproughton which taken together are bounded by an imaginary which taken together are bounded by an imaginary line commencing at the point where the boundaries of the parishes of Saint Thomas, Ipswich; Sproughton and Saint Mary, Stoke, all meet in the middle of the Ipswich and Norwich main railway line of British Railways (Eastern Region) and extending thence southeastwards along the middle of the said railway line to the centre of the bridge which carries the said railway line over Ancaster Road thence southwards along the middle Ancaster Road thence southwards along the middle of Ancaster Road to a point opposite the middle of the eastern end of Gippeswyk Avenue thence westwards to and along the middle of Gippeswyk Avenue to a point opposite the northern end of the eastern side of Birkfield Drive thence souththe eastern side of Birkfield Drive thence south-westwards to and along the eastern side of Birkfield Drive to a point in the middle of the eastern junction of Birkfield Drive with Stone Lodge Lane thence eastwards along the middle of Stone Lodge Lane to a point opposite the northeastern corner of close numbered 681 thence southwards to and along the eastern boundary of the last mentioned close to the northeastwards along the northeastern boundary of the last mentioned close and in a straight line in continuation thereof to the middle of Belstead Road thence southwestwards along the middle of Belstead Brook on the boundary of the County Borough of Ipswich thence first generally westwards then generally northwards and then generally northeastwards along the said County Borough boundary to the point where wards and their generally hothleastwards along the said County Borough boundary to the point where the boundaries of the parishes of Sproughton, Saint Mary, Stoke, and Saint Thomas, Ipswich, all meet."

"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend Harry, Bishop of Oxford (in witness whereof he has signed this Scheme), for effecting the praign of the benefice of Chaddienters. for effecting the union of the benefice of Cheddington and the benefice of Mentmore, both situate in the diocese of Oxford.

" SCHEME

"1. Union of Benefices. The benefice of Cheddington and the benefice of Mentmore shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Cheddington with Mentmore' but the parishes of the said benefices shall continue in all respects distinct.

"2. Taking effect of union. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend Colin George William Wood if he is then incumbent of both of the said benefices of Cheddington and Mentmore shall, with his consent (testified by his signature hereto) be the first incumbent of the united benefice and his admission thereto shall be without any form of, or fee for, presentation or nomination and he shall not be required to pay any fees in respect of his collation, institution, licence or induction to the united benefice beyond such fees as he would have been liable to pay if his admission to the united benefice had been an admission solely to that one of the said two benefices for the holding of which in plurality with the other a Dispensation was heretofore granted to him.

"3. Parsonage House. Upon the union taking effect the parsonage house at present belonging to the benefice of Cheddington shall be the house of residence of the incumbent of the united benefice." 3. Parsonage House.
