At the Court at Buckingham Palace, the 15th day of June 1959.

Present,

The QUEEN'S Most Excellent Majesty in Council Whereas the Minister of Housing and Local Government, after giving to the Incumbent and Churchwardens of the Parish of Cold Ash, in the county of Berkshire, 10 days' previous notice of his intention in that behalf, has, under the provisions of the Burial Act, 1853, as amended by subsequent enactments, made a Representation to Her Majesty in Council that, for the protection of the Public Health, the opening of any new burial ground in the Civil Parish of Cold Ash, in the said county of Berkshire, save with the previous approval of the Minister of Housing and Local Government, should be prohibited and that burials should be discontinued therein as follows, viz.:

Cold Ash.—Forthwith and entirely in the Old Chuchyard of St. Mark's Church, Cold Ash, in the said Parish.

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such Representation and to order that the same be taken into consideration by a Committee of the Privy Council on the 5th day of August next.

And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the Churches or Chapels of, or on some conspicuous places within, the Parish affected by such representation one month before the said 5th day of August.

The QUEEN'S Most Excellent Majesty in Council

Whereas the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 4th day of June 1959, in the words and figures following, that is to say:

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and humbly lay before Your Majesty in Council the following Scheme for constituting a new parish to be taken out of the parish of Temple Balsal in the diocese of Birmingham.

" SCHEME

"Whereas we, the Church Commissioners, are satisfied that the spiritual interests of the area defined in the Schedule hereto and delineated on the map hereto annexed would be best served by constituting it a new parish:

"And whereas we are satisfied that a suitable endowment thereof will be provided:

"And whereas we have not approved any consecrated church within the area as suitable to be the parish church of the new parish:

"Now, therefore, with the consent of the Right Reverend Leonard, Bishop of Birmingham (in testimony whereof he has set his hand and affixed his
