"And whereas the terms of such transfer are in our opinion fair and reasonable: "Now, therefore, we humbly recommend and pro-"Now, therefore, we humbly recommend and propose, with the consent of the Dean and Chapter of the Cathedral Church of Lichfield, and with the consent of the Right Reverend Arthur Stretton, Lord Bishop of Lichfield, as Visitor of the said Dean and Chapter, testified by their having hereunto affixed their respective corporate seals, that upon and from the publication in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme, and without any further conveyance or act in the law, the messuages, dwellinghouses and premises known as Numbers 3, 7, 10 and 12a, The Close, Lichfield and Numbers 1 to ld (consecutive) The Vicars Close, Lichfield, together with the outbuildings and appurtenances and the land forming the sites thereof respectively and held and enjoyed or occupied thereof respectively and held and enjoyed or occupied therewith (which said premises are coloured red upon the tracing annexed hereto) shall, subject always to the liabilities and charges, if any, to which the said property may now be specifically liable and to the leases or tenancies under which the same are respectively occupied be transferred to the said Dean and Charter in the manner contemplated by the main tively occupied be transferred to the said Dean and Chapter in the manner contemplated by the said Act, and that they shall be entitled to the rents, profits and proceeds of the said premises as from the First day of April in the year One thousand nine hundred and fifty-nine and that in consideration of such transfer as aforesaid the payment of the said annual sum of Five thousand four hundred and thirty-one pounds shall be reduced by the sum of Three hundred and one pounds Eighteen shillings as from the said First day of April in the year One thousand nine hundred and fifty-nine. "And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament."

And whereas the said Scheme has been approved by Her Majesty in Council:
