PUBLIC HEALTH (IMPORTED FOOD) REGULATIONS, 1937 & 1948

The Minister of Agriculture, Fisheries and Food gives notice in pursuance of the above-named regulations, that he hereby recognises the official certificate of which particulars are given in the schedule hereto as showing (a) that the meat from which the meat product was prepared was derived from animals inspected ante and post mortem and passed in accordance with criteria satisfactory to the Minister and (b) that all necessary precautions for the prevention of danger to public health were taken in the preparing and packing of the meat product.

The certificate being in the form of a label, recognition will apply only if the label is securely affixed to the container or package containing the meat product and has not in any other circumstances or on any other occasion been used as an official certificate.

The certificate hereby recognised is additional to the one reproduced in Part XV of the schedule to the notice published in the *London Gazette* of 6th August, 1937.
