Oxfordshire Development Plan

Notice is hereby given that on the 20th day of July 1959, the Minister of Housing and Local Government amended the above Development Plan to provide for

- (i) the allocation as primarily for industrial use of most of about 86.4 acres of land on the west side of Southam Road, Banbury, on which there is a valid planning permission for industrial development;
- (ii) the allocation of part of the rest of the area as primarily for residential use; and
- (iii) the definition of the remaining part of the area and other land as a principal traffic road and as the site of an improvement to the trunk road A.423.
