The said new archdeaconry shall comprise the Rural Deaneries of Cockermouth and Workington, Whitehaven, and Keswick, now forming part of the Archdeaconry of Westmorland, and there shall be transferred to the said new archdeaconry the Rural Deanery of Mary-port now forming part of the Archdeaconry port, now forming part of the Archdeaconry of Carlisle, and the Rural Deanery of Gosforth, now forming part of the Archdeaconry of Furness.

"2. The name of the Archdeaconry of Westmor-land shall be changed to 'The Archdeaconry of Westmorland and Furness' and there shall be trans-ferred to the said archdeaconry the Rural Deaneries of Dalton, Ulverston and Cartmel, now forming part of the Archdeaconry of Furness.

"3. The Archdeaconry of Furness shall cease to exist and the endowments of the said archdeaconry shall be transferred to the archdeaconry to be known as the Archdeaconry of Westmorland and Furness."
