PRESENT,

The QUEEN'S Most Excellent Majesty in Council Whereas the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 15th day of October, 1959, in the words and figures following, that is to say:—

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parishes of Basingstoke and Worting, both in the diocese of Winchester.

"Whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

"And whereas the Right Reverend Alwyn, Bishop of Winchester, consents to the proposed arrangements (in testimony whereof he has executed this Scheme):

"Now, therefore, we, the said Church Commissioners, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes of Basingstoke and Worting shall be altered in the manner described in the Schedule hereto and delineated on the map annexed to this Scheme.

"THE SCHEDULE .

"The territory to be annexed to the parish of Basingstoke:—

"All that part (coloured pink on the map annexed hereto) of the parish of Worting which comprises the Berg Estate and lies to the north of the middle of Pack Lane and to the east and south of the western and northern boundaries of close numbered 228A on the map."

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and submission of this Scheme, have been duly complied with:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

And Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Winchester.
