#### PRESENT,

The Queen's Most Excellent Majesty in Council Her Majesty, in exercise of the powers conferred upon Her by sections 659 and 738 of the Merchant Shipping Act, 1894, 57 & 58 Vict. c. 60, and section 1 of the Merchant Shipping (Amendment) Act, 1920, 10 & 11 Geo. 5, c. 2, and of all other powers enabling Her in that behalf and by and with the advice of Her Privy Council, doth order, and it is hereby ordered, as follows:

1.—(1) This Order may be cited as the Trinity House (Remuneration of Members) Order, 1959, and shall come into operation on the date of publication in the London Gazette.\*

(2) The Trinity House (Remuneration of Members) Order, 1957, printed in the London Gazette, 22nd February 1957, is hereby revoked.

(3) The Interpretation Act, 1889, 52 & 53 Vict. c. 63, shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament. Parliament.

2. The sum to be paid to the active members of the Corporation of the Trinity House of Depatord Strond, being the General Lighthouse Authority for England and Wales, shall be £30,800 per annum in respect of any period after 31st January 1959.

Provided that, in respect of any period during which there is a vacancy among the active mem-

which there is a vacancy among the active members, the said sum shall be reduced by an amount equal to the sum which, but for the vacancy, would

have been payable during that period to the active member concerned.

3. The sum payable under the provisions of this Order shall be paid out of the General Lighthouse

#### PRESENT.

The Queen's Most Excellent Majesty in Council Whereas the Church Commissioners have duly pre-pared and laid before Her Majesty in Council a Scheme bearing date the 23rd day of October 1959, in the words and figures following, that is to say:

"We, the Church Commissioners, acting in pursu-nce of the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend Russell, Bishop of Southwell (in witness whereof he has signed this Scheme), with respect to the former parish church of the parish of Christ Church, Newark-on-Trent, in the diocese of Southwell.

#### "SCHEME

"Whereas (1) by an Instrument under our Common Seal dated the 1st day of October, 1958, made pursuant to the New Parishes Measure, 1943, a new church situate within the parish of Christ Church, Newark-on-Trent, was substituted as the parish church in the place of the former parish church (hereinafter called the former parish church) of the said parish:

"(2) the former parish church has ceased to be

"(2) the former parish church has ceased to be used for the purposes of Divine Service:

"Now, therefore, we, the said Church Commissioners, humbly recommend and propose to Your Majesty in Council that upon the date of publication in the London Gazette of any Order of Your Majesty in Council affirming this Scheme the former parish church shall be appropriated to the uses specified in the Schedule hereto but subject to the conditions so specified.

#### " SCHEDULE

"1. The former parish church shall be held by the Southwell Diocesan Board of Finance (hereinafter called 'the diocesan authority') on trust to allow the same to be used as a warehouse or repository for general storage purposes, subject to the following conditions:

"(a) that the diocesan authority may enter into an agreement or agreements with any person or body
