with regard to the use of the former parish church for the said purposes and upon consequential and ancillary matters in connection therewith not being repugnant to or inconsistent with the provisions of

this Scheme, (b) that nothing herein contained shall affect or diminish the jurisdiction of the Consistory Court of diminish the jurisdiction of the former navish church the diocese in respect of the former parish church,

(c) that the freehold of the former parish church shall not be disposed of by the diocesan authority.

"We, the Church Commissioners, acting in pursu-ance of the Pastoral Reorganisation Measure, 1949, and the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend Tom, Bishop of Hereford (in witness whereof he has signed this Scheme) for effecting (1) the union of the benefice of Preston-on-Wye with Blakemere and part of the benefice of Moccas with Monnington, and (2) the union of the benefice of Byford with Mansel Gamage and the remaining part of the benefice of Moccas with Monnington, all of which benefices are situate in the diocese of Hereford.

" SCHEME

"1. Union of the benefice of Preston-on-Wye with Blahemere and part of the benefice of Moccas with Monnington.

"(1) That part of the benefice of Moccas with Monnington which coincides with the area of the parish of Moccas shall be severed from the said benefice and the part so severed and the benefice of Preston-on-Wye with Blakemere shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Moccas with Preston-on-Wye and Blakemere,' but the parishes of Moccas, Preston-on-Wye, and Blakemere shall continue in all respects distinct.

"(2) Parsonage house. Without prejudice to the (2) Parsonage house. Without prejudice to the exercise before the date when the union takes effect of any of the powers conferred by the Parsonages Measures, 1938 and 1947, upon the union taking effect the parsonage house at present belonging to the benefice of Mioccas with Monnington shall, if at that date it so belongs to the said benefice, be the house of residuence of the increment of the interview. of residence of the incumbent of the united benefice.

"(3) Patronage. In every series of three successive turns of presentation to be made to the united benefice after the union has taken effect, the patrons of the benefice of Preston-on-Wye with Blakemere shall have the first and third turns and the patron of the benefice of Moccas with Monnington shall have the second turn.

"2. Union of the benefice of Byford with Mansel Gamage and the remaining part of the benefice of Moccas with Monnington.

"(1) That part of the benefice of Moccas with Monnington which remains after the severance there-from of the area referred to in Clause 1 (1) of this Scheme, namely that part which coincides with the area of the parish of Monnington, and the benefice of Byford with Mansel Gamage shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Byford and Mansel Gamage with Monnington,' but the parishes of Byford, Mansel Gamage, and Monnington shall continue in all respects distinct.

"(2) Parsonage house. Without prejudice to the exercise before the date when the union takes effect of any of the powers conferred by the Parsonages Measures, 1938 and 1947, upon the union taking effect the parsonage house at present belonging to the benefice of Byford with Mansel Gamage shall, if at that date it so belongs to the said benefice, be the house of residence of the incumbent of the united benefice.

"(3) Patronage. In every series of three successive turns of presentation to be made to the united benefice after the union has taken effect, the patron of the benefice of Byford with Mansel Gamage shall have the first and third turns and the patron of the benefice of Moccas with Monnington shall have the second tum.

"3. Taking effect of unions. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the unions hereinbefore recommended and proposed shall forthwith take effect and the Reverend Reginald Bennett Sisson, if he is then incumbent of the said benefice of Moccas with Monnington shall, with his consent (testified 1by his signature hereto), be the first in-cumbent of the united benefice of Moccas with Preston-on-Wye and Blakemere.

"4. Distribution of endowments belonging to the benefice of Moccas with Monnington. Upon the taking effect of the unions hereinbefore recommended and proposed the endowments and property now be-longing to the benefice of Moccas with Monnington shall be divided and distributed as follows, that is to say, there shall be assigned and annexed to the united benefice of Byford and Mansel Gamage with Monnington a capital sum of £7,493 is. 4d. now producing an annual income of £250 and being part of a larger capital sum held by us for the said benefice of Moccas with Monnington, and all other the endowments and property belonging to the said benefice of Moccas with Monnington shall be assigned and annexed to the united benefice of Moccas with Preston-on-Wye and Blakemere.
