(d) The parish shall be in the Archdeaconry of Maidstone and in the rural deanery of East

Charing.

The boundaries of the said parishes of Ashford and Willesborough shall be altered in the manner described in Part II of the said Schedule and as the said Schedule and as the said Schedule and the said Sched delineated on the map hereto annexed and the boundaries of the said parishes of Ashford and Kingsnorth shall be altered in the manner described in Part III of the Schedule and as delineated on the map hereto annexed.

# "THE SCHEDULE

# "Part I

"The new parish of Christ Church, South Ashford: -

"The area coloured pink on the map annexed hereto comprising

(a) All that part of the parish of Ashford (excluding that part hereinafter annexed to the parish of Kingsnorth) which lies to the south of the middle of the Tonbridge to Ashford line and to the southwest and west of the middle of the Ashford to Hastings line of British Railways (Southern Berging) and

Ashford to Hastings line of British Railways (Southern Region), and

"(b) All that part of the parish of Kingsnorth which lies to the north of a continuous imaginary line commencing on the boundary which divides the parish of Great Chart from the parish of Kingsnorth at a point in the middle of the road which leads from Great Chart past Greyhole Shaw, to Washford Farm and Brisley Farm and continuing thence southeastwards along the middle of the aforesaid good to its junction. Farm and continuing thence southeastwards along the middle of the aforesaid road to its junction with the road which leads to, and along the southern boundary of, Stanhope School and continuing thence northeastwards along the middle of the last mentioned road to the boundary which divides the parish of Kingsnorth from the parish of Ashford.

"All that part (coloured green on the map) of the parish of Ashford which lies to the south of the middle of the road which runs along the southern boundary of Stanhope School and leads to Ellingham Farm and Kingsnorth."
