"(a) All that part (coloured blue on the map) of the parish of Charlwood which lies to the east of the middle of the River Mole and to the south of Gatwick

(b) All that part (coloured green on the map) of the parish of Horley which is bounded on the south-west by the parish of Charlwood and on the remaining sides by a continuous imaginary line commencing on the boundary which divides the last mentioned parish from the parish of Horley at a point opposite the western end of the southern boundary of close numbered 1445 and continuing thence eastwards along the aforementioned boundary to its end and thence in a straight line in the same direction to the western end of the northern boundary of close numbered 1459 (thereby crossing the London to Brighton line of the British Railways (Southern Region)) thence northeastwards along the last mentioned boundary and southeastwards along the northeastern boundary of the last mentioned close and thence first eastwards then southeastwards along the northern and northeastern boundaries of close numbered 1460 thence northeastwards, southeastwards and southwestwards along eastwarus, soumeastwards and southwestwards along the northwestern, northeastern and southeastern boundaries of close numbered 1461 and the southeastern boundary of close numbered 1470 and in a straight line in continuation thereof to the boundary which divides the parish of Honley from the parish of Charlwood."
