

"Now, therefore, we, the said Church Commissioners, humbly recommend and propose that so soon as conveniently may be after the day when any Order of Your Majesty in Council affirming this Scheme is published in the *London Gazette* :

"1. The site of the said former church of Saint George, Hornsey, together with any ground annexed thereto and necessary for the use and enjoyment thereof shall be sold or disposed of by us at such time or times and in such manner in all respects as to us shall seem expedient subject to the conditions and restrictions imposed by the said Measures.

"2. The net proceeds to arise from such sale shall be placed to the credit of the expenses fund of the diocese of London established pursuant to the 32nd Section of the Union of Benefices Measure, 1923."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1952, and the Union of Benefices Rules, 1926 and 1930, relating to the preparation and submission of this Scheme have been duly complied with:

Whereas the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 13th day of November 1959, in the words and figures following, that is to say:

"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Honourable and Most Reverend Michael, Archbishop of York, (in witness whereof he has signed the Scheme) for effecting (1) the union of the benefice of Seaton Ross with Everingham and Harswell and a part, namely the Chapelry of Bielby, of the benefice of Hayton with Bielby and (2) the union of the benefice of Shipton Thorpe and the remaining part of the said benefice of Hayton with Bielby; all of which benefices are situate in the diocese of York.

"SCHEME

"1. *Union of the benefice of Seaton Ross with Everingham and Harswell and part of the benefice of Hayton with Bielby.*

"(1) (a) That part (coloured pink on the map annexed hereto) of the benefice of Hayton with Bielby which coincides with the area of the civil parish of Bielby and contains the chapelry of Bielby shall be severed from the said benefice and the part so severed and the benefice of Seaton Ross with Everingham and Harswell shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Seaton Ross with Everingham and Bielby and Harswell'.

"(b) That part of the parish of Hayton with Bielby which coincides with the part of the benefice of Hayton with Bielby severed in accordance with the preceding sub-section shall be united to the parish of Everingham to form one parish for ecclesiastical purposes under the style of 'The parish of Everingham and Bielby' and the parish church of the parish of Everingham shall be the parish church thereof, but the said parish of Everingham and Bielby and the parishes of Seaton Ross and Harswell shall continue in all respects distinct.

"(2) Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the *London Gazette* the union shall forthwith take effect and the Reverend Donald Burnett if he is then incumbent of the benefice of Seaton Ross with Everingham and Harswell shall, with his consent (which has been given to us in writing), be the first incumbent of the united benefice.

"(3) Without prejudice to the exercise before the date when the union takes effect of any of the powers conferred by the Parsonages Measures, 1938 and 1947, upon the union taking effect the parsonage

house at present belonging to the benefice of Seaton Ross with Everingham and Harswell shall, if at that date it so belongs to the said benefice, be the house of residence of the incumbent of the united benefice.

"(4) In every series of three successive turns of presentation to be made to the united benefice after the union has taken effect the patron of the benefice of Hayton with Bielby shall have the first turn, the alternate patron of the benefice of Seaton Ross with Everingham and Harswell who but for this scheme would be entitled to make the next presentation to that benefice shall have the second turn and the other alternate patron of the said benefice of Seaton Ross with Everingham and Harswell shall have the third turn.

"2. *Union of the benefice of Shipton Thorpe and the remaining part of the benefice of Hayton with Bielby.*

"(1) (a) The benefice of Shipton Thorpe and that part of the benefice of Hayton with Bielby not united with the benefice of Seaton Ross with Everingham and Harswell under clause 1 (a) hereof shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Shipton Thorpe with Hayton'.

"(b) That part of the parish of Hayton with Bielby not united with the parish of Everingham under clause 1 (b) hereof shall be known as 'The Parish of Hayton' and the said parish of Hayton and the parish of Shipton Thorpe shall continue in all respects distinct.

"(2) Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the *London Gazette* the union shall forthwith take effect and the Reverend Norman Crawshaw if he is then incumbent of the said benefice of Shipton Thorpe shall, with his consent (which has been given to us in writing), be the first incumbent of the united benefice.

"(3) Without prejudice to the exercise before the date when the union takes effect of any of the powers conferred by the Parsonages Measures, 1938 and 1947, upon the union taking effect the parsonage house at present belonging to the benefice of Shipton Thorpe shall, if at that date it so belongs to the said benefice, be the house of residence of the incumbent of the united benefice.

"3. *Endowments.*

"Upon the taking effect of the unions hereinbefore recommended and proposed a capital sum of £4,240 6s. 9d. being part of a larger capital sum at present held by us for the endowment of the benefice of Hayton with Bielby, shall be assigned and annexed to the united benefice of Seaton Ross with Everingham and Bielby and Harswell and all other the endowments and property belonging to the said benefice of Hayton and Bielby, including the parsonage house of the said benefice, shall be assigned and annexed to the united benefice of Shipton Thorpe with Hayton."
