The Import Duty Drawbacks (No. 1/1) Order, 1959.

This Order increases the rate of drawback of import duty on certain imported goat and kid skins used in the manufacture of exported skins of dressed leather.

The Order comes into operation on 3rd December 1959, and has been published as Statutory Instru-ments 1959, No. 2011.
