## WAGES COUNCILS ACT, 1959

*Tin Box Wages Council (Great Britain)*

The Tin Box Wages Council (Great Britain) hereby gives notice of its intention to submit to the Minister of Labour proposals for (1) increasing the statutory minimum remuneration set out in the Wages Regulation (Tin Box) Order, 1957 (Order X (50)) as amended by the Wages Regulation (Tin Box) (Amendment) Order, 1958 (Order X. (52)) and (2) the revocation of Order X. (50) and Order X. (52).

The Wages Council will consider any written representation with respect to the above-mentioned proposals which may be sent to it within twenty-one days from 15th December 1959.
