

of any of the powers conferred by the Parsonages Measures, 1938 and 1947, upon the union taking effect the parsonage house at present belonging to the benefice of Saint Philip, Hulme, shall, if at that date it so belongs to the said benefice, be the house of residence of the incumbent of the united benefice.

"5. *Patronage.* With the consent (which has been given to us in writing) of the Dean and Canons of the Cathedral and Collegiate Church of Saint Mary, Saint Denys and Saint George in Manchester, being the patrons of the benefices of All Saints, Chorlton-on-Medlock, and Holy Trinity, Hulme, the consent (testified as aforesaid) of the Right Reverend William, Bishop of Manchester, being the patron of the benefice of Saint John the Baptist, Hulme, and the consents (which have been given to us in writing) of Herbert Lewis Birley of 63 Heaton Road, Withington, Manchester, 20, Esquire, Philip Lander Birley of Fern Cottage, Aldenley Edge, Cheshire, Esquire, and Barbara Fernandez Birley, care of Mrs. E. G. F. Birley, 29 Sandhurst Avenue, Manchester, 20, Spinster, being the patrons of the benefice of Saint Philip, Hulme (hereinafter called 'the Birley Trustees'), upon the union taking effect the patronage of the said benefices of All Saints, Chorlton-on-Medlock, Holy Trinity, Hulme, and Saint John the Baptist, Hulme, shall, without any conveyance or assurance other than this Scheme, be surrendered in favour of the said Birley Trustees and the patronage of the united benefice shall belong wholly to the Birley Trustees, subject to the same trusts, powers and provisions as their original patronage of the benefice of Saint Philip, Hulme.

"6. *Sale of church site.*

"(1) As soon as conveniently may be after the union has taken effect the site of the former church of Saint John the Baptist, Hulme, together with any ground annexed thereto and necessary for the use and enjoyment thereof, shall be sold and disposed of by us at such time or times and in such manner in all respects as to us shall seem expedient subject to the conditions and restrictions imposed by the said Union of Benefices Measures.

"(2) The net proceeds to arise from such sale or sales, after payment of the expenses attendant thereon and all other expenses incidental thereto, shall be applied by us as follows, that is to say:—

"(a) so much of the net proceeds as we, after consultation with the Bishop of Manchester, shall determine shall be applied by us towards the cost of erecting a new church in a statutory district or parish in the said diocese to be selected by the Bishop of Manchester.

"(b) the balance (if any) of the said net proceeds shall be placed to the credit of the Expenses Fund of the said diocese established pursuant to the 32nd Section of the Union of Benefices Measure, 1923."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1952, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the preparation and submission of this Scheme have been duly complied with:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to affirm the said Scheme and to order that it shall be and become effectual in law immediately upon the publication of this Order in the *London Gazette*.

Whereas the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 15th day of December 1959, in the words and figures following, that is to say:

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parishes of Saint Helens; Saint Mark, Saint Helens; All Saints, Rainford; Up Holland; Billinge; Saint Luke, Eccleston; Christ Church, Eccleston; Saint Thomas, Eccleston; Holy

Trinity, Parr Mount; Saint Peter, Parr; Saint John the Evangelist, Ravenhead; Sutton; Saint Ann, Rainhill; Saint Matthew, Thatto Heath; Farnworth; Saint Mark, Haydock; Saint Michael, Burton Wood; Saint Bartholomew, Roby; Huyton; and Saint John the Evangelist, Knotty Ash, all in the diocese of Liverpool.

"SCHEME

"Whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

"And whereas the Right Reverend Clifford, Bishop of Liverpool, consents to the proposed arrangements (in testimony whereof he has executed this Scheme):

"Now, therefore, we, the said Church Commissioners, humbly recommend and propose that from and after the day of the date of publication in the *London Gazette* of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes of Saint Helens; Saint Mark, Saint Helens; All Saints, Rainford; Up Holland; Billinge; Saint Luke, Eccleston; Christ Church, Eccleston; Saint Thomas, Eccleston; Holy Trinity, Parr Mount; Saint Peter, Parr; Saint John the Evangelist, Ravenhead; Sutton; Saint Ann, Rainhill; Saint Matthew, Thatto Heath; Farnworth; Saint Mark, Haydock; Saint Michael, Burton Wood; Saint Bartholomew, Roby; Huyton; and Saint John the Evangelist, Knotty Ash, all in the diocese of Liverpool shall be altered in the manner described in the Schedule hereto and delineated on the map annexed to this Scheme.

"THE SCHEDULE

"1. *The territory to be annexed to the parish of All Saints, Rainford:*

"(a) All that part (coloured pink on the map lettered A annexed hereto) of the parish of Up Holland which lies to the southwest of an imaginary line commencing at a point on the boundary which divides the parish of All Saints, Rainford, from the parish of Up Holland in the middle of the foot-bridge at King's Moss Farm which crosses Black Brook and extending thence generally southeastwards in a straight line to the northwestern end of the southwestern boundary of close numbered 713 (thereby crossing Pimbo Road and closes numbered 12, 13, 26, 794, 707, 705 and 712) and thence southeastwards along the last mentioned boundary to its end and in continuation thereof in the same straight line to the boundary which divides the parish of Up Holland from the parish of Billinge.

"(b) All that part (coloured green on the map lettered A annexed hereto) of the parish of Billinge which lies to the northwest of an imaginary line commencing at a point on the boundary which divides the parish of Up Holland from the parish of Billinge in the middle of Crank Road opposite to the southeastern end of the southwestern boundary of close numbered 713 and extending thence first southeastwards to the southeastern side of Crank Road and then in the same straight line for a distance of 50 yards and thence southwestwards parallel to the southeastern side of Crank Road to the boundary which divides the parish of Billinge from the parish of All Saints, Rainford.

"2. *The territory to be annexed to the parish of Saint Luke, Eccleston:*

"(a) All that part (coloured pink on the map lettered B annexed hereto) of the parish of Christ Church, Eccleston, which lies to the east and north of an imaginary line commencing at a point on the boundary which divides the parish of Christ Church, Eccleston, from the parish of Saint Helens in the middle of Kilm Lane and extending thence southwestwards along the middle of the last mentioned Lane to a point opposite the middle of Alder Hey Road thence southwards to and along the middle of the last mentioned Road to its end and in the same straight line to the middle of Knowsley Road thence generally eastwards along the middle of Knowsley Road to the boundary which divides the parish of Saint Luke, Eccleston, from the parish of Christ Church, Eccleston.

"(b) All those parts (coloured green on the map lettered B annexed hereto) of the parish of Saint Helens which lie to the south of the middle of Windle Brook, to the southeast of the middle of Dilloway Street, to the southwest of the middle of Lingholme Road, and to the northwest of the middle of Boundary Road.
