

lies to the north of the territory described in paragraph 1 of this Schedule and to the south of an imaginary line commencing at a point on the boundary which divides the parish of Budbrooke from the parish of Saint Mary, Warwick, in the middle of Birmingham Road and proceeding thence first eastwards then southeastwards along the middle of Birmingham Road and Saltisford to the boundary which divides the parish of Saint Paul, Warwick, from the parish of Saint Mary, Warwick, thence first generally southwards then generally southeastwards then generally northeastwards along the last mentioned boundary to the point where the last mentioned boundary turns westwards to meet Castle Lane, thence in a straight line southeastwards across Warwick Castle Park in the direction of the western corner of the Boat House situate in close numbered 2839 to a point in the middle of the River Avon on the boundary which divides the parish of Saint Mary, Warwick, from the parish of Saint Nicholas, Warwick.

"3. *The territory to be annexed to the parish of Saint Mary, Warwick:*

"All that part (coloured purple on the map annexed hereto) of the parish of Saint Nicholas, Warwick, which lies to the south and west of an imaginary line commencing at a point on the boundary which divides the parish of Saint Mary, Warwick, from the parish of Saint Nicholas, Warwick, in the middle of Millers Road and proceeding thence eastwards along the middle of Millers Road to a point opposite the northern end of the eastern boundary of the house and premises known as No. 118 Millers Road, thence southwards to and along the last mentioned boundary and along the eastern boundary of the house and premises known as No. 113 Wathen Road to the boundary which divides the parish of Saint Nicholas, Warwick, from the parish of Saint Mary, Warwick.

"4. *The territory to be annexed to the parish of All Saints, Emscote:*

"All that part (coloured red on the map annexed hereto) of the parish of Saint Nicholas, Warwick, which lies to the north of an imaginary line commencing at a point on the boundary which divides the parish of All Saints, Emscote, from the parish of Saint Nicholas, Warwick, in the middle of Emscote Road opposite the middle of the northwestern end of the unnamed path or roadway leading from Emscote Road into Saint Nicholas Meadow and proceeding thence southeastwards to and along the middle of the last mentioned path or roadway to a point opposite the southwestern end of the northwestern boundary of the premises of the Park Laundry, thence first northeastwards to and along the last mentioned boundary then southeastwards along the northeastern boundary of the last mentioned premises to a point opposite the middle of the southwestern end of Meadow Road, thence northeastwards along the middle of Meadow Road to the boundary which divides the parish of Saint Nicholas, Warwick, from the parish of All Saints, Emscote."

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and submission of this Scheme, have been duly complied with:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the *London Gazette* pursuant to the said Measure.

And Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Coventry.

Whereas the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 31st day of December 1959, in the words and figures following, that is to say:

"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the

consent of the Right Reverend Robert, Bishop of Peterborough (in testimony whereof he has signed this Scheme), for effecting the union of the benefice of Pattishall and the benefice of Cold Higham, both situate in the diocese of Peterborough.

"SCHEME

"1. *Union of Benefices.* The benefice of Pattishall and the benefice of Cold Higham shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Pattishall with Cold Higham', but the parishes of the said benefices shall continue in all respects distinct.

"2. *Taking effect of union.* Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the *London Gazette* the union shall forthwith take effect and the Reverend Ronald Harcourt Horton if he is then incumbent of both of the said benefices of Pattishall and Cold Higham shall, with his consent (which has been given to us in writing), be the first incumbent of the united benefice and his admission thereto shall be without any form of, or fee for, presentation or nomination and he shall not be required to pay any fees in respect of his collation, institution, licence or induction to the united benefice beyond such fees as he would have been liable to pay if his admission to the united benefice had been an admission solely to that one of the said two benefices for the holding of which in plurality with the other a Dispensation was heretofore granted to him.

"3. *Parsonage House.* Without prejudice to the exercise before the date when the union takes effect of any of the powers conferred by the Parsonages Measures, 1938 and 1947, upon the union taking effect the parsonage house at present belonging to the benefice of Cold Higham shall, if at that date it so belongs to the said benefice, be the house of residence of the incumbent of the united benefice.

"4. *Patronage.*

"(1) With the consent (testified as aforesaid) of the Right Reverend Robert, Bishop of Peterborough, being the patron of the benefice of Yelvertoft with Clay Coton and Lilbourne in the said diocese, and with the consent (which has been given to us in writing) of the Martyrs Memorial and Church of England Trust of Falcon Court, 32 Fleet Street, in the City of London (hereinafter called 'the said Trust'), being the patron of the benefice of Cold Higham, upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the *London Gazette* and without any conveyance or assurance in the law other than such duly gazetted Order, the whole right of patronage of and presentation to the benefice of Cold Higham shall be transferred from the said Trust to and become vested in the said Robert, Bishop of Peterborough, and his successors in the same Bishopric for ever and in exchange for the same the whole right of patronage of and presentation to the said benefice of Yelvertoft with Clay Coton and Lilbourne shall be transferred from the said Robert, Bishop of Peterborough, to and become vested in the said Trust.

"(2) After the union has taken effect the right of presentation to the united benefice shall be exercised by the patrons of the benefices of Pattishall and Cold Higham alternately, the patron of the benefice of Pattishall having the first presentation to the united benefice to be made after the union."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1952, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the preparation and submission of this Scheme have been duly complied with:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to affirm the said Scheme and to order that it shall be and become effectual in law immediately upon the publication of this Order in the *London Gazette*.
