REGULAR ARMY

Regular officers of the substantive rank of major and Regular officers of the substantive rank of major and below who were appointed to permanent Regular Army commissions between 15th August 1942, and 18th October 1949, and who were serving on the Active List on 1st November 1959, will with effect from that date reckon service given before their 211st birthday towards seniority and time promotion, provided the seniority does not thereby date from before the 21st birthday the 21st birthday.

This supplement contains the names of those officers whose seniority in the rank on the 1st November 1959, is altered as the result of this revised calculation of seniority. In the case of certain officers referred to in this Supplement, alterations to seniority which have been made in the past are cancelled, and their dates of seniority and of promotion to ranks junior to that held on 1st November 1959, are restated in this Supplement.

ment refer either to:

(a) precedence in the Army consequent upon this

revision of seniority.

This is included only when two or more officers in the Army have a common date of seniority; or (b) the dates of London Gazette (Supplement) in

which earlier notification of revised seniority and promotion dates was made.
