SOUTHAMPTON CORPORATION

(Alteration of Work)

Notice is hereby given that when the Bill (hereinafter referred to as "the Bill") now pending in Parliament under the above name or short title was considered by the Committee of the House of Lords to whom the Bill was referred (in which Right Honourable House the Bill originated) provision was made for an alteration of the levels and mode of construction of the proposed bridge over the river Itchen (Work No. 5) as described in the Bill as introduced into Parliament and delineated on the plans and sections deposited in connection therewith in the month of November 1959, with the Town Clerk of the Borough of Southampton.

The alteration of work aforesaid will be situate wholly in the Borough of Southampton and comprises the following work proposed to be constructed in substitution for the said bridge (Work No. 5):

Substituted Work No. 5. A bridge over the river Itchen having a central span with—

- (a) a clear width at water level of not less than three hundred and fifty feet; and
- (b) a headway above high water of ordinary spring tides of not less than eighty feet throughout the central width of not less than one hundred feet thereof;

commencing near the western bank of the said river at the inlet to the north of Floating Bridge Road and terminating on the eastern bank of the said river to the west of Hazel Road and eighty yards or thereabouts north-west of the junction of Hazel Road and Oakbank Road.

The Mayor Aldermen and Burgesses of the Borough of Southampton (the Promoters of the Bill) accordingly intend, if the Bill becomes law, to construct the proposed substituted work aforesaid according to the levels shown on the substituted sections hereinafter referred to, subject to the powers of deviation contained in the Bill, and with spans of altered dimensions to the west and east of the central span of the said bridge (Substituted Work (No. 5) as described in the Bill and as delineated on the said substituted sections.
