#### PRIVY COUNCIL OFFICE

At the Court at Buckingham Palace the 8th day of April 1960,

PRESENT. The QUEEN'S Most Excellent Majesty in Council

Whereas by section 3 of the Naval and Marine Pay and Pensions Act, 1865 (28 & 29 Vict. c. 73), it is and Pensions Act, 1805 (28 & 29 vict. c. 13), it is enacted that all pay, wages, pensions, bounty money, grants or other allowances in the nature thereof payable in respect of services in Her Majesty's naval or marine force to a person being or having been an officer, seaman or marine, or to the widow or any relative of a deceased officer, seaman or marine, shall

be paid in such manner, and subject to such restrictions, conditions and provisions, as are from time to time directed by Order in Council:

And whereas Her Majesty deems it expedient to amend the Order concerning retired pay, pensions and other grants for officers, nurses and ratings disabled, and for the widows and children of officers and ratings deceased, in consequence of service during the 1914 World War:

Now, therefore, Her Majesty, in exercise of the powers conferred upon Her as aforesaid and of all other powers whatsoever Her thereunto enabling, is pleased, by and with the advice of Her Privy Council,

pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

The Order in Council dated the 29th September 1949, relating to officers, nurses and ratings as therein defined, as amended by the Orders in Council dated the 28th October 1949, the 31st March 1950, the 31st May 1951, the 29th April 1952, the 18th July 1952, the 28th May 1953, the 5th January 1955, the 29th June 1956, the 24th January 1957, the 27th November 1957, and the 13th May 1959, shall be further amended in the respects set out in the following Articles of this Order in Council, which shall be construed as one with the said Order of the 29th September 1949.

1. In proviso (a) to paragraph (1) of Article 5 (which provides for the supplementation of retired pay or pension and the award of allowances for unemployable pensioners) for the figures £52 there shall be substituted the figures £104.

2. This Order shall come into operation on the 1st May 1960.

## EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport)

This Order amends the Order of the 29th September 1949, as amended by subsequent Orders, and increases, from £52 a year to £104 a year, the maximum amount which a pensioner may earn and nevetheless be deemed to be unemployable for the purpose of an award of the allowances for unemployable pensioners. Now, therefore, Her Majesty, in exercise of the powers conferred upon Her as aforesaid and of all other powers whatsoever Her thereunto enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

The Order in Council dated the 29th September 1949, relating to members of the naval forces as therein 1949, relating to members of the naval forces as therein defined, as amended by the Orders in Council of the 28th October 1949, of the 31st May 1951, of the 29th April 1952, of the 18th July 1952, of the 28th May 1953, of the 5th January 1955, of the 29th June 1956, of the 24th January 1957, of the 27th November 1957, and of the 13th May 1959, shall be further amended in the respects set out in the following Articles of this Order which shall be construed as one with the said Order of the 29th Sentember 1949 with the said Order of the 29th September 1949.
