#### PRESENT.

The QUEEN'S Most Excellent Majesty in Council.

Whereas there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 24th day of March 1960 (N.P. 5160/59) in the words following,

viz.:
"Whereas by Section 3 of the Naval and Marine
Pay and Pensions Act, 1865, it is enacted, inter alia
that all pay, pensions or other allowances in the nature that an pay, pensions or other anowances as the nature thereof payable in respect of service in Your Majesty's Naval or Marine Forces to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas by Order in Council dated 28th January, 1958, sanction was given to introduce revised Service retired pay and pensions regulations for Officers and men in order to provide compensation for those whose careers are prematurely terminated, and to provide special resettlement grants for those retiring under existing regulations.

under existing regulations: "And whereas by Section IV of Schedule II to Order in Council dated 28th January, 1958, as amended by Order in Council dated 3rd June, 1958, amended by Order in Council dated 3rd June, 1958, sanction was given to award a special resettlement grant to any Royal Naval rating or Royal Marine who leaves the Royal Navy after 4th April, 1957, on completion of, or on invaliding when engaged to complete, engagements totalling not less than 22 years' service, or 15 years' service of which the last 10 years should have been continuous:

"And whereas we deem it expedient to make provision for the award of a special recettlement grant

vision for the award of a special resettlement grant to those Royal Marines whose services have been prolonged under Section V of the Royal Marines Act, 1847, or under paragraph 4 (3) of the Seventh

Schedule to the Army Act, 1955, provided that the man has given the full three months' notice of termination required by the regulations:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased to approve by Your Order in Council the addition of a sub-clause in the terms set out below to Section IV of Schedule II to Order in Council dated 28th January, 1958, as amended by Order in Council of 3rd June, 1958.

"(f) The grant may be awarded to a Royal Marine whose services have been prolonged under Section V of the Royal Marines Act, 1847, or under paragraph 4 (3) of the Seventh Schedule to the Army Act, 1955, provided that the man has given the full three months' notice of termination as required by the Acts."

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this

proposal

Her Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of Her Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly. W. G. Agnew.
