### FACTORIES ACTS, 1937 TO 1959

The Minister of Labour hereby gives notice that on 18th July 1960, he made the Washing Facilities (Miscellaneous Industries) Regulations 1960 (S.I. 1960 No. 1214), under sections 46 and 60 of the Factories Act, 1937. These Regulations provide that the requirements as to washing facilities imposed by a number of Orders and Regulations under the Factories Acts shall not be in substitution for, or in diminution of, the statutory requirement under the Factories Act, 1959, section 18 (1), that the washing facilities for the use of employed persons shall include a supply of clean running hot and cold or warm water.
