### WAGES COUNCILS ACT, 1959

#### *Tin Box Wages Council (Great Britain)*

The Tin Box Wages Council (Great Britain) hereby gives notice of its intention to submit to the Minister of Labour proposals for (1) varying the statutory minimum remuneration set out in the Wages Regulation (Tin Box) Order, 1960 (Order X (54)) and (2) the revocation of Order X (54).

Particulars of the proposals may be obtained on application to the Secretary of the Wages Council at the address given below.

The Wages Council will consider any written representation with respect to the above-mentioned proposals which may be sent to it within fourteen days from 9th September 1960. Any such representation should bear the writer's address and signature and be sent to the Secretary, Tin Box Wages Council (Great Britain), Ebury Bridge House, Ebury Bridge Road, London S.W.1. It is desirable that persons making objections should state the precise nature of their objections.
